2021-22 President's Report

This report is to highlight the achievements and conduct of Helensburgh-Stanwell Park Surf Life Saving Club in its 114th season of serving the public and providing a safe environment for the pubic to use Stanwell Park Beach, training life savers, competing at surf carnivals and providing a breeding ground for future life savers.

It was a season like no other, that started with the club being named SLSNSW Club of the Year, followed by COVID-19 Patrolling Restrictions, and then what seemed like the wettest summer with the worst continuous run of surf conditions in living memory including a Tsunami warning, and ending with the club being named 2021/22 SLSI Patrolling Club of the Year.

Again the club patrolled Stanwell Park Beach without the loss of life, participated in local surf sports events across Branch, State and Australian Championships, ran a Nippers program promoting a healthy mix of skills and competition, opened the doors of the club to the public on some Friday and Saturday nights, hosted private functions, saw the return of Yoga, Dance and table tennis group during the week, supported Surf Life Saving Illawarra in a number of key areas, and promoted lifesaving in the local community.

Life Saving

The club formed 7 patrols with an average of 10 members to patrol Stanwell Park Beach throughout the season with members contributing 37 hours on patrol. Of the 92 proficient lifesavers, 23 fulfilled 100% of their patrol requirements during season. On top of their rostered patrols, many members exceeded their requirements thru voluntary patrols, swaps, as well as Emergency Callout, UAV Patrols, Water Safety and supporting other patrols.

The patrolling season began under COVID-19 Restrictions that were put in place by SLSNSW to help control the spread of the virus within the clubs and community. The restrictions included limiting the number of patrol members, all day patrols to avoid a cross-over of members, and no members under 16 (due to vaccinations not being available to them at that stage). The club adopted these restrictions by rostering full day patrols which ran until early November 2021, the club chose to run these beyond the restrictions being lifted so all patrols experienced full day patrols. After restrictions lifted, the patrols returned to the normal 2 patrols per day for the balance of the season. The "Emergency Callout Team" continued maintaining their skills and capability throughout the season, fortunately only a few callouts during the season but no on-water involvement was required. The team ran a training scenario involving a trip north to the Royal National Park followed by locating a number of persons in the water at the southern end of the beach. The team practised line searching to locate people in the water. The club acquired a full-sized mannequin during the season to assist with training. Again, the UAV provided support in locating people in the water as well as being a great tool to document the training.

Visitor numbers to the Stanwell Park Beach declined in comparison with the 2020/21 season, with only an estimated 27,500 visitors during the season. The decline can be contributed to COVID-19 travel restrictions early in the season, poor weather and surf conditions during the season. It certainly felt like there were more days with the beach closed than open.

The club's UAV activities reduced due to NSW Department of Primary Industries locating a UAV at Stanwell Park Beach to fly 8 hours per day, 7 days per week over the Summer and Easter School Holidays. Despite the increased UAV activity there were only a few marine life sightings, and none were considered threatening species.

The club's "Rescue Ready" capability is well supported, the power craft team making available 4 IRB's, 6 motors and 2 ATV's available to patrols.

Many thanks to all members who patrolled during the season, congratulations to the 23

members who met 100% of the patrol commitment, and thank you to the Patrol Captains and Vice-Captains for managing resources effectively and efficiently to patrol Stanwell Park Beach.

The club was recognised by Surf Life Illawarra as the Patrolling Club of the Year. The nomination reflected the clubs ongoing efforts to improve the delivery of surf life saving service on Stanwell Park Beach, as well as building on the strength of the clubs "Emergency Callout Team". The club was able to demonstrate a public focused approach to patrolling, ensuring the swimming public understood the safest places to swim at the beach...always "Between the Red & Yellow Flags", our patrol members increased the amount of time spent patrolling the water's edge preventing swimmers from getting into trouble. The "Emergency Callout Teams" contribution to the club always being #RESCUEREADY also played a part in being recognised. The award is a culmination of many seasons developing our life savers skills and the response appropriate to а changing demographic on Stanwell Park Beach...well done to all our patrolling members and the members who support them.



Competition

The club has seen very little activity in the competition arena during the season other than our Masters Boat Crew, Sea Wolves IRB Racing Team and our Nippers.

The Sydney Water Series was cancelled for the 2021/22 Season and replaced by a couple of smaller local carnivals, almost like carnivals in the 1970's and 80's, but poor weather and hazardous surf conditions limited the competitions. It really was a season impacted by bad weather and bad surf.

The Masters Boat Crew had one row in the South Coast Boat Series event at Broulee, and subsequent to that surf conditions became too hazardous to compete for such a young crew...they are already preparing for season 2022/23.

The Sea Wolves IRB Racing Team were back in action, competing in all 4 rounds of the NSW

Sharkskin IRB Premiership and the NSW Sharkskin IRB Championship. They had an outstanding season, with a 3rd place in the IRB Premiership for the Rookie Mass Rescue, and at the State Championship 1st in the Rookie Mass Rescue, 2nd and 3rd in the Rookie Rescue. Under the leadership of Anthony Ashley and Mathew Webber the team is really starting to perform, they have a well-trained set of drivers and crews in the Rookie, Open, U23, 35+ and 45+ categories. The other clubs are starting to take notice of the Sea Wolves. A big thanks to Josh Cole (Terrigal SLSC) and Melissa Gorgijovski (Wollongong City SLSC) for being our officials this season, the plan is for the club to have at least one club member as an official in the 2022/23 Season.

The Nippers competed at the local Illawarra Carnivals, Illawarra Branch and a very wet NSW Age Championships. Well done to all of our nippers who got in and had a go. It was great to see Hallie Bostik win a Silver Medal in the U10 Female Beach Flags at the NSW Age Championships.

Year on year, the club is fortunate to have members officiating at various carnivals up and down the coast, a big thanks to Mark Thompson, Carl Williams and Bobo White for continuing to support the club at all levels of competition, along with several other members who have assisted throughout the season. Well done to Carl Williams on being named SLSI Surf Sports Official of the Year, Carl is extraordinary in the execution of his role on the beach, he is cool as a cucumber when competitors emotions are at their highest.

Junior Activities - Seagulls

Our nippers seem to just get better and more enthusiastic every season, a small drop in number to 159 members but not in excitement or drive to learn about life saving and improve their skills. Continued improvement in the water with another increase in water competitors at the few carnivals held during the season.

The U13 and U14 Nippers Leadership Camp capped off our U14's time at Nippers with some adventures around Stanwell Park a feature of the camp. The camp is designed to give our U13 and U14 the confidence to continue into the senior club as patrol members and hopefully lifelong members of the club.

Weekly Board Training Sessions continued throughout the season weather and surf condition dependant, but it is paying off with a bunch of our nippers participating in water events at carnivals. The training is providing them with the skills necessary to have a crack in events longer than what are done at Sunday morning nippers. Well done to the Seagulls Committee and Water Safety Team for continuing to drive this initiative.

The club transitioned 6 nippers into the Senior club and onto patrols, with them completing their Surf Rescue Certificate. Another great group of quality nippers to bolster the club's patrolling strength. A big thanks to Russ Taunton, Karl Weber, Anthony Rooskie and Peter McDonald for their ongoing support of the clubs SRC training program.

A new Junior Activities Committee for the season with Lee Bailey covering the first half of the season and Justin Larkin taking the reigns in the second half as Junior Chairperson, and new Secretary Celia Heffernan did a great job keeping the nippers engaging and well managed and well informed thanks to Christine McDonald for her up to date postings of the goings of the Nippers on Instagram and the setting up of an Ap. Well done to the whole Junior Activities Committee.

None of the above programs would run without the dedication and support of the Water Safety Team, they put in huge hours in all conditions to look after the club's nippers and ensure that they are safe and confident in the water.

Sea Eels Winter Swimming Group

Thanks to Covid the swimming season was once again interrupted although the club did manage five swims, a visit to the Bulli Sea Lions and a visit by the ladies from the Bondi Icebergs, despite the interruptions the club presented our major charity with a \$3200.00 donation.

Members Development and Training

A solid season in Education despite being heavily impacted by COVID-19 Restriction. A focus was put on ensuring patrol members proficiency was maintained in the first instance. As COVID-19 Restrictions relaxed award training commenced.

6 Surf Rescue Certificates, 4 Bronze Medallion, 2 IRB Crew and1 IRB Driver awards were completed, along with 4 Probationary TAF's. The club appreciates all members who continue to build on the clubs patrolling capability by gaining new awards, especially our junior members that make the transition from nippers to patrol members by gaining their Surf Rescue Certificate.

An encouraging season in terms of building the Education Team up, with 4 Probationary Training, Assessor and Facilitators (TAF's) in progress, including Anthony Rooskie, Mathew Webber, Karl Weber and Russ Taunton. This new capability will ensure the club can continue to train members in various essential awards for patrols.

Well done to Anthony Rooskie on a successful season in his first season as Chief Training Officer and thank you to all members who contributed to training our members.

Member Retention

For the 5th season in a row, the Member Retention section of the Presidents Report remains basically unchanged.

"Retaining members in a voluntary organisation is always a challenge with so many competing interests, it is hard to inspire members to give up their time to stand on the water's edge and watch out for people that they have no relationship with. Fortunately, we have nearly 100 members who willingly do this, but how do we keep them in the club and what opportunities can the club give them?

Surf Boat Rowing is great for retention, as you need 4 members for a crew plus a sweep that gives you 5 patrol members, another crew another 5 patrol members, and so on.

The Sea Wolves IRB Racing Team is building and has seen some new members join the club, this is an activity that generates interest in the club. The events are fast, furious and fun, they improve the skills of the IRB Driver and Crew along with fostering teamwork and camaraderie.

I encourage members to get involved in club activities, to look beyond just the patrolling aspect and embrace all of club life. Drag your friends to the beach, to club functions, to Friday Night Drinks and give them a glimpse into surf club life outside of patrol duties. They may not all join up, but another 1 member is better than no new members.

If you have an idea for the club or a program you would like to run, then talk to the committee we are all ears!"

The club is working on making patrolling more flexible and programs to build the patrolling strength and club membership. The "U13 and U14 Nippers Leadership Camp" is all about retaining members as they move from Nippers to the senior club, and the Sea WASSP's program is all about getting parents involved in the club.

2020/2021 - Surf Life Saving NSW Club of the Year

An amazing result for the club being named Surf Life Saving Club of the Year. The club followed on the success of being named 2020/21 Surf Life Saving Illawarra Club of the Year.



On the same basis that the club won the branch award, a nomination was submitted to SLSNSW to represent the branch. Along with the Strategic Plan, the club has been engaged with the community, seen a big increase in beach attendance, maintain a strong patrolling presence on Stanwell Park Beach, upgraded the skills of its life savers, developed nippers to be more than just a Pointscore, celebrated 40 Years of Women in Life Saving, ran successful "Emergency Callout Team" training scenarios, promoted surf lifesaving in the local media, started work on "Making The Surf Club Accessible", participated in competition at all levels and been contributor to Surf Life Saving Illawarra in a number of key areas.

The award recognised the great work done by the club's membership in the 2020/21 season, and in the seasons leading up to the 2020/21 season. A key feature of the nomination was to ensure that the club's 2020-2023 Strategic Plan aligned with the 2025 Surf Life Saving Australia Strategic Plan and the 2018-2021 Surf Life Saving New South Wales Strategic Plan. The plan focused on growing the club, aligning it with community expectations, strengthening our commitment to surf life saving not only on the beach but beyond the normal bounds of the patrolling lifesaver.

Following this success Surf Life Saving NSW nominated the club for Surf Life Saving Australia Club of the Year. The process included a written nomination as per the previous 2 awards and a formal presentation/interview with a board of selectors from around Australia. Codie Weber and Steven McDonald were the face of the club, assisted by Anthony Rooskie. A presentation that highlighted all the great programs the club has run over the past season, as well as talking about the history of the club and its community impact. Codie did a great job and spoke confidently about the impact surf life saving has had on her life as well as the success of the clubs' U13 & U14 Leadership Camp. Unfortunately, the club was not successful in winning the award, but just getting to the final was a great to the whole club.

"Making the Club Accessible" Project

Progress during the season was impacted due to COVID-19 which limited access to the surf club and hence delayed visits to the club for consultants and contractors. At the end of the season, the club is in a position to submit a DA for the "Make The Club Accessible Project".

All of the outstanding consultants' reports required by Wollongong City Council were completed and the design modifications required have been made. Although none of the modifications required have seen a deviation from the projects original intent and the DA will present a design to Wollongong City Council that will result in an accessible building that enhances the club's ability to provide surf life saving services on Stanwell Park Beach.

The DA will present a design to WCC that includes,

- Accessible toilets on the Ground and 1st Floor
- A lift providing access to all levels of the building
- Relocation of the Patrol Room providing better sight lines to both ends of the beach
- Dedicated Nipper Storage directly accessible from the front of the building
- Extending the Life Saving Gear Storage (IRB, Boat and Board Shed) forward by 3m
- Terrace on the south-east corner of the building
- Access to the top of the Lifeguard Shed from the clubhouse, which will provide the club with an outdoor BBQ area
- Veranda along the full length of the club
- Extending the stairwell to access all level of the building, including a Clock to be visible from the beach
- A redesigned Training Room, Office and Storage Space
- A redesigned Bar and Kitchen Space
- Modern toilet, shower and changerooms on the Ground Floor
- Space for a Gym

- A Registration/Information Space on the Ground Floor

Funding of this project will be challenging, with the club having to draw funding from available grants, local, state and federal infrastructure grants, contribution from Wollongong City Council, and support from club members, the 2508 community and local businesses.

Unfortunately, this is a long process, and having observed progress made by other clubs in the Illawarra a very challenging and trying experience for all involved. But we are determined to make it happen as the result will be an awesome space for our surf life savers, and a tremendous and accessible community asset.

Finally

To the Executive and Management Committee, thank you for your support during the season, we are making great progress with sponsorship activities, patrols are great, competition is thriving, and club governance is strong.

Thanks to every member who contributed to the on-going success of the club.



At the beginning of March, a callout was sent asking for members to help with the NSW floods that had started to grip the State. A massive amount of people offered their time to help, including:

Shortly after the first call was received Mat Webber and Anthony Ashley were sent to Nowra down at the South Coast Surf Life Saving Base to meet up with 11 other SLSNSW clubs which involved 18 IRBs and over 50 Surf Life Saving members.

After setting up a base camp and waiting on the next move from SurfCom, a brief was held via an online video link joining Surf Life Saving Clubs spanning from the top of NSW in the Tweed area all the way down to Batemans Bay. The situation had become one of the biggest combined emergency call out operations the State had ever seen.

Meanwhile a second team was put on standby back at Helensburgh - Stanwell Park surf club with Steve McDonald & Lachlan McDonald waiting anxiously for the call to go.

After 24 hours of waiting for the next step, a brief was held down at Nowra, the decision was made to split into smaller deployment teams and spread out around the NSW flood affected areas.

Mat Webber and Anthony Ashley were first sent to Liverpool then Bass Hill then finally Blacktown. After multiple stops, meetings, briefs and sandbag filling the Helensburgh-Stanwell Park team were stood down and sent back to Stanwell Park. This included the second team still waiting at Stanwell Park.

2 days later,

A report came in that a boat had capsized at Stanwell Park.

Again, the emergency call-out team sprang into action with Allan Manning and Guy Ezzeddine racing to the surf club and setting up for deployment. It was quickly established that the boat had washed away from Bulgo beach in the rough seas luckily no one was in the boat. After a few hours the boat was taken away by water rescue.

1 day later,

Another emergency call out was sent to the club asking for more help with the NSW Floods. This time Lachlan McDonald and Karl Webber were set and ready to go. As everyone watched the rain fall more and more it was almost certain the team would be sent. At the last minute the team was told to stand down.

This was a real test of character for the Emergency callout area. Every single one of these members have offered their time to help others. I am so proud of each and everyone of them. Thank you so much for all that you did, it may feel that you did not achieve much but the fact you were there ready to do whatever it takes is a true test of Helensburgh -Stanwell Park culture. Thank you from all of us.

Phil Kelly Secretary The Year in Review: a deficit of \$30,451 was recorded for the 2021-22 year after factoring in depreciation expenses of \$46,678.

Income: \$226,144, an increase of \$109,210 compared to the 2020-21 year, with increased income from Government grants, donations, sponsorship and fund raising activities, and a transfer of \$35,471 from the Building Fund.

Expenditure: \$256,595, an increase of \$69,808 compared to the 2020-21 year. Almost 85% of the increase was associated with costs for preparation of the Development Application for the building accessibility upgrade.

 \$62,866 was received from donations, sponsorship and fundraising activities, an increase of \$37,506 compared to the previous year.

\$40,674 was received from Government grants, an increase of \$22,508 compared to the previous year.

\$45,376 was expended on asset renewals, including an ATV, IRB hull and five rescue boards. A further \$2,850 was expended on renewal of other low value assets.

Covid restrictions from end-June 2021 impacted income from function hires and refreshment sales, with the NSW Government providing Covid relief grants to minimise the impact on the Club.

Financial Position

At 31.03.2022, cash at bank (operating accounts) was \$75,921. \$34,395 of this amount was either income accrued to be spent in 2022-23 year, or income held for the IRB and surf boat teams, and membership and other fees paid in advance.

A contingency amount of \$20,711 was invested in a Term Deposit to cover damage to the Club building up to \$20,000, for which the Club is liable under the terms of the building lease.

\$88,445 was held in the Building Extensions Fund. \$68,052 of this was invested in a term deposit, with a further \$20,393 is to be transferred from the Business-On-Line account into a second Term Deposit.

At 31.03.2022, the Club was not in debt to any supplier (other than within 30 day trading terms). At 30.06.2022, this statement was still valid.

\$2,783: Wollongong City Council, annual grant for lifesaving patrol operations.

Financial Management

All income and expenditure was managed on a whole-of-Club basis using MYOB accounting software. This facilitated preparation and submission of Business Activity Statements (GST) and these Financial Statements.

Finance Reports were tabled at monthly Executive Committee meetings listing individual payments for approval, and a summary of income received.

Audited Financial Statements

The Financial Statements were prepared as a Special Purpose Financial Report to meet the reporting requirements of the Associations Incorporation Act (NSW) 2009, the Charitable Fundraising Act (NSW) 1991, and the Australian Charities and Not-for-Profits Commission Act (Cth) 2012 and associated regulations.

Paul Mattock, of Evolve Small Business Accounting, Coledale again undertook the audit of the Club's accounts, with the Auditors report included in the Financial Statements (pages 47-48) towards the end of this Annual Report.

Recommendations arising from a review by Surf Life Saving NSW of our (and all other NSW Clubs) 2020-21 Financial Statements for compliance with accounting requirements, have been adopted and the 2021-22 Financial Statements follow various Australian Accounting Standards and include additional detail in the Notes.

Explanatory Notes

The Financial Statements cover the 12 month period ending 31.03.2022.

All income and expenditure recorded in the Financial Statements and throughout this Annual Report, is shown (unless otherwise stated) as net amounts exclusive of GST collected, or GST paid, where applicable.

Club overheads including building utilities, cleaning and maintenance, affiliation fees, membership levies and other administrative expenses are apportioned across the whole Club on an approximate membership pro-rata basis, this year 60% seniors and 40% Junior Activities.

Income and Expenditure Statements for individual sections are included in the Financial Statements (pages 49 and 50).

Whole of Club result

The deficit of \$30,451 includes \$46,678 for depreciation of Club assets.

Club/senior section

A surplus of \$1,067 was recorded.

Government grants, donations and sponsorship income was higher than 2020-21, and with relaxation of Covid restrictions, income from hire of the surf club and bar trading showed increases compared to 2020-21.

\$35,472 was transferred from the Building Fund to repay expenses paid initially from Club bank accounts for consultants to prepare the Development Application for the building accessibility upgrade.

Almost \$50,000 was expended on asset renewals for an IRB hull, ATV, five rescue boards, six rescue tubes and other patrol equipment.

Value of saleable stock on hand at 31.03.2022 totalled \$4,860 - bar stock \$3,358, clothing stock \$1,502.

Junior Activities

A surplus of \$494 was recorded, after committing \$4,830 to place an order for a further six training boards to be delivered in the 2022-23 season.

Fundraising activities generated net income of \$5,786 - Santa Photos \$3,701, and \$1,644 from the Christmas raffle.

Income from clothing sales totalled \$2,403 whilst Sunday morning food and refreshments generated a small surplus.

Clothing stock on hand at 31.03.2022 was valued at \$3,260.

Winter Swimming

The 2021 season ran from 2 May 2021 until 26 June 2021 when Covid restrictions were re-introduced and all Sunday swims cancelled.

Through donations and a major raffle, a total of \$4,534 was raised, with \$3,000 of

that donated to Cram Foundation. A further \$1,472 was donated to the surf club and other charitable organisations.

A deficit of \$549 was recorded. Clothing stock on hand at 31.03.2022 was valued at \$1,014.

Building Fund

At 31.03.2021, the Building Fund balance was \$118,786. Bank interest (\$955) and half bar surplus (\$4,175) were added during the year.

After transferring \$35,472 to the Club bank account for consultancy services to complete the Development Application, and adding bank interest and half bar surplus, the Building Fund balance at 31.03.2022 was \$88,445.

Appreciation

The Club's financial position is positive thanks to financial support from the Australian and NSW Governments, Wollongong City Council and SLSA, SLSNSW, and SLS Illawarra, as well as our regular donors, our members and the local community.

Thank you to our donors many of whom were also impacted by Covid restrictions, for your continuing support of the Club during the year.

Whilst keg beer is purchased wholesale from Lion Beer, packaged beer and wine are purchased from local retailers - our thanks particularly go to Helensburgh Premium Liquor, Glenbernie Orchard and Stanwell Cellars for your support.

A special thank you to Club officers who helped with management of our financial recording and reporting obligations, and our members who identified and pursued opportunities to obtain donations and other income through fund raising activities. Without your personal efforts, the Club's finances would not be as healthy.

The Club has been registered as a charitable organisation with the Australian Charities and Not-for-Profits Commission since 29.01.2013.

Governance and Club Management

The Club is an Incorporated Association established under the provisions of the *Associations Incorporations Act* (NSW) 2009.

The Club Constitution and By Laws were updated and approved by members at the 2020 Annual General Meeting. At the date of this report, the Constitution was in the process of being updated to meet requirements of all regulatory bodies and bring it in line with the latest SLSA and SLSNSW Constitutions. On completion, a Special General Meeting of members will be convened to adopt the revised Constitution.

Executive Committee

As defined in the Constitution, the Club's affairs are controlled by the Executive Committee of eight elected officers. Sub-committees including the Lifesaving Committee, Education Committee, Junior Activities Committee, Surf Sports Committee and Winter Swim Committee all report to the Executive Committee.

Special General Meetings

A Special General Meeting to elect the Junior Activities Committee and officers for the 2022-23 season was held on 20.03.2022.

Junior Activities Committee

The Junior Activities Committee dealt with dayto-day matters autonomously and held regular meetings during 2021-22.

Stanwell Park Sea Eels

Covid restrictions introduced on 26 June 2021 resulted in winter swimming activities being cancelled for the remainder of the season.

The Annual General Meeting and election of officers for the 2022 season took place on 02.05.2021.

Objects of the Club

The Objects of the Club are to:

- Provide for the conduct, encouragement, promotion and administration of surf lifesaving;
- (b) Participate as a Member of Surf Life Saving Illawarra, Surf Life Saving New South Wales and Surf Life Saving Australia through and by which surf lifesaving and the preservation of life in the aquatic environment can be conducted, encouraged, promoted, advanced and administered;

- (c) At all times act on behalf of and in the interest of the Members and surf lifesaving;
- (d) Affiliate with and otherwise liaise with SLSI, SLSNSW and SLSA in the pursuit of these Objects and surf lifesaving;
- (e) Promote the involvement and influence of surf lifesaving standards, techniques, awards and education with bodies involved in lifesaving;
- (f) Prepare junior members for admittance as surf lifesavers;
- (g) Promote competition at Club and interclub level for junior and senior members;
- (h) Review and/or determine any matters relating to surf lifesaving which may arise, or be referred to it, by any Member;
- Pursue through itself or other such commercial arrangements (which are not in conflict with other SLS bodies), including sponsorship and marketing opportunities as are appropriate to further the interests of surf lifesaving;
- (j) Represent the interests of its Members and of surf lifesaving generally in any appropriate forum;
- (k) Have regard to the public interest in its operations;
- (l) Undertake and/or do all such things or activities which are necessary, incidental or conducive to the advancement of these Objects.

Affiliation with SLSA

Members at the Annual General Meeting on 15.08.2021 and the adjourned meeting on 26.09.2021 resolved to apply for continuing affiliation with Surf Life Saving Australia for the 2021-22 year.

Audit of Accounts 2021-22

The Financial Statements for the 12 months ended 31.03.2022 were approved at the Executive Committee meeting on 07.06.2022. The accounts were audited by Paul Mattock of Evolve Small Business Accounting.

The Financial Statements and Auditors Report are reprinted on pages 35 to 50.

Financial Reporting 2020-21 year

The Financial Statements for year ending 31.03.2021 including Auditors Report, were published as part of the Club's 2021-22 Annual Report.

The Annual Information Statement for the 2020-21 financial year was lodged on-line with ACNC on 27.09.2021.

Charitable Fundraising

As required by the *Charitable Fundraising Act* 1991, the Club is required to submit an audited Financial Report covering its operations each year, together with a signed declaration of compliance with the Act.

This obligation was met by forwarding a copy of the audited Financial Statements to Surf Life Saving NSW, which holds the 'Authority to Fundraise' on behalf of all NSW surf clubs. The Financial Statements were submitted during October 2021

GST reporting

Business Activity Statements were submitted to the Australian Taxation Office at the end of each quarter, the last Statement being submitted for quarter ending 31.03.2022.

Insurance

Surf Life Saving Australia has arranged public liability and property loss and damage for all surf life saving clubs through Marsh Insurance.

The insurance proposal was completed and submitted on 29.07.2021, for policies covering loss or damage to assets valid to 01.10.2021. Public Liability Insurance (\$50 million), is also in place and valid to 07.10.2022.

Members continue to be covered for medical expenses incurred due to injuries whilst involved in an approved surf club activity through the NSW Government scheme for volunteer workers.

Working with Children Checks

The Executive Committee continues to ensure Club officers and members who, as part of their Club activities become associated with members under the age of 18 years, have a current Working with Children clearance. This is undertaken by following SLSNSW guidelines, as well as meeting the requirements of the *Child* Protection (Working with Children) Act 2012, and Child Protection (Working with Children) Regulation, 2013.

At 30 June 2022, 26 members were recorded with a current WWCC clearance.

Environmental management

Continual oversight of Club activities is undertaken by Executive Committee members to minimise environmental risks from spills whilst refuelling IRBs and ATVs within the boat shed and paved outdoor area. Similar to previous years, the risk was mitigated by having two spill kits located in the boat shed, and briefing of IRB crews and patrol members on their duty of care.

Liquor Licence

The Club continues to hold an On-Premises Liquor Licence for Stanwell Park Surf Club (LIQO 660031060). Harley Dreghorn is the Licence Manager, appointed from 06.09.2017.

New Liquor and Gaming NSW signage relating to underage drinking was installed in the Club premises during the year.

In accordance with the Licence Conditions, the Club continues to be a member of the Wollongong LGA Liquor Accord, with the Licence Manager attending quarterly meetings.

No incidents relating to the Liquor Licence were recorded during the year.

Motor Vehicle Registration

Motor vehicle registration is current for three surf boat trailers, gear trailer and two ATVs.

Membership overview

Total membership was 403 compared to 439 in 2020-2021 year.

Membership Registrations

On-line member renewal and new registrations were again promoted this year, in an endeavour to minimise contact as part of Covid safety precautions, with only a small number of paper membership forms completed.

The majority of our members also assisted the clerical effort with prompt payment of membership fees through either the SLSA Online payment facility or by direct deposit to the Club's bank account.

Thanks to our two registrars Lorna Dreghorn and Emma Reid for your management of the

registration and payment of fees by our 400 members, and for assisting members complete on-line renewals and new registrations

Helensburgh-Stanwell Park Surf Life Saving Club Inc is an Association incorporated in New South Wales in 1995 under the provisions of the Associations Incorporation Act (NSW) 2009. The Executive Committee consisting of the following members at the date of this report, is the governing body of the Association:

The Association is a not-for-profit organisation operating as a surf life saving club and emergency service organisation in the Stanwell Park district.

1 Basis of preparation

The Executive Committee has determined that the Association is not a reporting entity and this report has accordingly been prepared as a Special Purpose Financial Statement, covering all operations and activities of the Association as an individual entity for the 12 months ended 31 March 2022.

The Financial Statements were prepared to meet the reporting requirements of the *Australian Charities and Notfor-Profits Commission Act* (Cth) 2012, as well as the *Charitable Fundraising Act* (NSW) 1991 and *Associations Incorporation Act* (NSW) 2009, and associated Regulations, and also to meet the requirements of the members of Helensburgh-Stanwell Park Surf Life Saving Club Inc.

The Financial Statements were prepared in accordance with various Australian Accounting Standards and Accounting Interpretations, and on an accruals basis, based on historical costs, modified where applicable by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

Estimates and judgements included in these Financial Statements are based on the Association's actual income and expenditure over the past two years and other known factors as well as proposed activities and projected budgets for the forthcoming financial year.

The following accounting standards relevant to charitable organisations and not-for-profit entities, apply:

- AASB 13: Fair value of Leases
- AASB 15: Revenue from Contracts with Customers
- AASB 16: Leases
- AASB 101: Presentation of Financial Statements
- AASB 107: Statement of Cash Flows
- AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors
- AASB 116: Property, Plant and Equipment
- AASB 137: Provisions, Contingent Liabilities and Contingent Assets
- AASB 1048: Interpretation of Standards
- AASB 1054: Australian Additional Disclosures
- AASB 1058: Income of Not-for-Profit entities

The application of these Standards has not resulted in any material changes to the Association's financial position, performance, or cash flow.

2 Summary of Significant Accounting Policies

(a) Revenue and other income

Other than as stated below, revenue is recognised when the amount of the revenue can be measured reliably, and it is probable that the economic benefit will flow to the Association.

(b) Sale of goods

Revenue is recognised at the time of transfer of goods to the customer when the risks and rewards are transferred and the Association no longer has ownership or control.

(c) Private Functions and Community Events

The 5-step process noted in AASB 15 is applied with revenue from private functions and community events recognised at the conclusion of the event when the Association can identify it has met its contractual obligations of providing an agreed service to a customer.

(d) Membership and related fees

Revenue from membership fees and other membership charges are recognised at the time of receipt, other than fees or charges received in advance for a subsequent membership year when the revenue is carried forward on the Balance Sheet.

(e) Donations and Sponsorship

Revenue is recognised in the Income and Expenditure Statement when received, unless designated for a special purpose or is subject to conditions, in which case revenue is recognised as a liability and carried forward on the Balance Sheet until used for the designated purpose or the conditions have been met.

(f) Grants

Grant revenue is recognised in the Income and Expenditure Statement when the Association obtains control of the grant funds, it is probable that the economic benefits gained will flow to the Association and the grant can be measured reliably.

When a grant is subject to conditions such as a designated use, time frame for completion, and/or acquittal obligations, revenue is recognised as a liability and carried forward on the Balance Sheet until such time as the conditions have been met.

Grants received to acquire or renew plant and equipment assets on a \$ for \$ basis or a nominal amount, are recognised as an addition to plant and equipment values on the Balance Sheet at fair value equal to their usual selling price at the date of acquisition. When this occurs, a corresponding amount of income comprising either grant funding or a donation amount, is recognised in the Income and Expenditure Statement.

Grants received to undertake leasehold works to the Club building are recognised as income in the Income and Expenditure Statement with the cost of asset improvement works carried as a property asset on the Balance Sheet.

(g) Inventories

Inventories are measured at the lower of cost and net realisable value.

(h) Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair value, less where applicable, any accumulated depreciation and impairment.

(i) Depreciation

Plant and equipment is depreciated on a reducing balance basis over the assets useful life to the Association, commencing from when the asset is first acquired.

Assets used for lifesaving, member training and development, and competition are depreciated at 20% over five years on a straight-line basis, whilst furniture, fittings and assets in use in the office, main hall, bar, kitchen and amenities, are depreciated at 15% over seven years on a straight-line basis.

The value of improvements to the leased premises occupied by the Association and completed in 2019, are depreciated at 15% over seven years on a straight-line basis.

All categories of plant and equipment acquired at a cost of less than \$3,000 are fully depreciated during the financial year of acquisition.

Assets acquired at a cost of less than \$1,000 are not capitalised, and are included as an expense in the Income and Expenditure Statement.

The Executive Committee reviews the depreciation methodology, useful life criteria and residual value of assets annually and introduces adjustments as required.

(j) Leases

The Association leases the Surf Club premises at Stanwell Park from Wollongong City Council at a peppercorn rental with right-of-use to occupy the premises for the sole purpose of furthering its Objectives as a surf life saving club. The Association has no other leases in place either financial or operational.

The Executive Committee has considered the implications of AASB 16 - Leases, AASB 13 - Fair Value of Leases, and AASB 2018-8 - Amendments to Australian Accounting Standards – Right-of-Use Assets of Not-for-Profit entities in relation to the Association's occupation of the Club premises as a lessee.

After review of the accounting standards, the Executive Committee has determined:

- the building lease is not classified as an operating or finance lease,
- the lease grants right-of-use to the Association solely for surf life saving operations and activities,
- the lease provides significantly below-market terms and conditions, and
- the below-market terms and conditions are primarily allowed by the Lessor to enable the Association to further its Objectives as a surf life saving club.

The accounting standards allow not-for-profit entities having right-of-use of leased premises and where the terms and conditions are below-market, to elect to measure the value of a lease at its initial recognition at cost, subject to disclosure of additional qualitative and quantitative information about the lease.

The Association has therefore elected to adopt this measure, and provides the following information about the building lease:

- Leased Premises: Helensburgh-Stanwell Park Surf Life Saving Club building 1 Beach Road, Stanwell Park, NSW 2508
- Lessor: Wollongong City Council
- Right-of-Use: The Association has exclusive rights to occupy and use the building for surf life saving operations and activities, other than the Council Lifeguards amenities room and equipment storage shed.
- Lease start date: 1 November 2018
- Term of lease: 21 years, expiring on 31 October 2039
- Lease payments: First year (2018-2019) \$690.00 (incl GST) payable in advance. Rental in subsequent years is varied annually according to Wollongong City Council's Community and Sporting Group annual rental charges.
- Payments to date: \$2,835 (incl GST) paid from 1 November 2018 to 31 October 2021.
- Value of lease: Over the first three years, annual rental has increased by approx 2.1%pa .to \$720 (incl GST). Assessed on a similar rate over the 21 year term, the total value of the lease is approximately \$15,790 (incl GST)
- Lease conditions: Summary (relevant conditions only). The Premises may only be used for surf life saving operations and activities, including activities associated with raising funds to further the Objectives of the Association. The Association as lessee is responsible for maintaining the interior of the Premises in good condition, and repairing any damage to the Premises up to a value of \$20,000.

3 Provisions

Provisions are recognised when the Association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

No amount has been allocated for Provisions in the reporting period.

4 Comparative Figures

This report is for the 12 month period commencing 1 April 2021 and ending 31 March 2022, with comparative figures for the 12 months ended 31 March 2021.

5 Income Tax

The Association is an Exempt Entity as defined in Section 50-5 of the *Income Tax Assessment Act* (Cth), 1997, as a charitable organisation registered with Australian Charities and Not-for-Profits Commission.

6 Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office. Receivables and payables are stated inclusive of GST.

The net amount of GST recoverable from the Australian Taxation Office for the period ending 31 March 2022, is included as a Sundry Debtor in item 11 – Trade and other receivables.

7 Cash and cash equivalents at end of financial year

Cash and cash equivalents include cash on hand, deposits held at call, and other short term investments which are readily convertible to known amounts of cash.

(a) Land and Buildings

The Association does not own any real property.

The Association leases the surf club building at 1 Beach Road, Stanwell Park from Wollongong City Council with the lease expiring in 2039. Refer Note 2(j) for details about treatment of the value of the lease as an asset.

Leasehold improvements to the building completed during the 2019-20 year are depreciated annually on a straightline basis over seven years as reported below.

The Association owns two shipping containers (with no residual asset value) used for storage of equipment, located on privately owned property at 225 Parkes Street, Helensburgh at nil rental under a reciprocal arrangement with the property owner.

During the 2020-21 year, the Association initiated a project to upgrade the surf club building to current accessibility standards and engaged consultants to prepare a Development Application. Funds for payment of consultant's fees were drawn from the Building Fund.

The Asset Renewal program supported by local businesses and Government grants, ensures our lifesaving and member development assets are renewed on a regular basis, whilst the Club's strategy of linking member subscriptions to utilities, insurances, building management and other general expenses associated with operating as an incorporated association, provides an on-going income source.

Restrictions on function hire and sale of refreshments caused by the Covid pandemic created a downfall in revenue over the past two years, but is expected to return to normal in the 2022-23 year.

The Executive Committee through development and monitoring of cash flows and budgets, is confident that the Association can continue to meet its obligations to pay accounts as and when they fall due.

The current project to upgrade the Club premises is not intended to affect the operating income and will only proceed after the Association has secured funding from other sources.
