## Report from Club Captain, Mathew White

It is a pleasure to report that no lives were lost whilst Club patrols were on duty with no serious injuries or incidents recorded.

This year all NSW surf clubs were required to enter into a contract agreement with Surf Life Saving NSW to undertake patrols in accordance with defined protocols (Standard Operating Procedures) and minimum levels of commitment in terms of patrol hours, qualified members and equipment.

I can confirm that the obligations in the Lifesaving Contract between the Club and SLS NSW for 2006-07 were fulfilled.

Our patrol obligations as specified in the Contract were:

- √ Patrol of Stanwell Park beach on Sundays and public holidays from Sunday 1 October 2006 until Wednesday 25 April 2007
- √ Patrol from 9.00 am to 5.00 pm, extended to 6.00 pm finish from Sunday 24 December 2006 until 28 January 2007
- √ A minimum of three Bronze Medallion holders on each patrol, with each patrol having a least one ARC holder, one IRB driver and one IRB crewperson, with no one member undertaking two of the above roles on the patrol.

Thanks to the efforts of our members, we achieved and exceeded these minimum requirements on every patrol.

Nine patrol teams were formed this season, with each patrol having an average of ten Bronze Medallion holders rostered. Over the season, the average attendance was six Bronze holders.

Thank you to the Patrol captains for the additional responsibilities which were readily accepted and preformed in a professional manner. Patrol Captains were Kieran Beaumont, Andrew Perrin, Scott Boyle, Carl Williams, Steven McDonald, Stuart Brandman, Russell White, Dave Astill and Dave O'Grady.

Thanks to those patrol members who took on the extra training and gained additional qualifications, with ARC, IRB Drivers, IRB crewperson and Defibrillator operator award holders needed on all patrols.

Our patrols ran so well this year because of a few members who took on extra roles and made my job that bit easier. My thanks to them -

- Nathan Thompson, Vice Captain, helped me whenever I was unavailable, and contributed on all matters regarding patrols.

# Beach patrols

---

- Sandra Dent, Patrol Secretary, who helped Nathan and myself with the mountain of paperwork involved these days and helped keep the patrol records up to date.
- Peter McDonald, Chief Instructor, and his team of trainers, for providing the patrols with new Bronze Medallion holders and Surf Lifesaving Cadets, and ensuring that a high standard was always maintained.
- Mark Stares who did not stand for IRB Captain this season but continued in the job, for ensuring there was always IRBs and IRB motors available for patrols and that the quad bike was always in good working order.
- Peter O'Halloran, Radio Officer, for maintaining our hand held and base radios despite them being beyond their "use by" date.
- Geoff Coleman, Chief First Aid Officer, for ensuring the first aid equipment was checked regularly, first aid boxes were always well stocked and maintained and the first aid room was always kept clean and ready to deal with any emergencies.
- Evan Griffiths, for under taking patrol inspections and running the patrol competition.
- And finally the Club Executive, for the support they have given Nathan and myself this year with any matters that have risen concerning the patrols.

In reporting on patrol inspections, Evan constantly gauged and monitored the efficiency and effectiveness of each and every patrol; his inspections assisted in ensuring that the patrols were diligent, well organised, and responsive to any incident that may arise on the beach, and that our public profile was kept at a high standard throughout the season. Included in the inspection reports are statistics on attendance, presentation and patrol uniforms, attention to the patrol area and general attitude towards patrolling duties.

Most patrols faired very well with the main problems being members without their patrol cap on, and a few members regularly late for patrols, late set up of patrol area in the mornings by some patrols and some patrols a little lax in completing log books. It should be clear and our members must appreciate that these regulations are not unique to Helensburgh-Stanwell Park club but are mandatory guidelines set down by Surf Life Saving Australia.

Apart from our commitment to patrolling Stanwell Park beach, the Club also has an obligation to provide 24-hour search and rescue support to the Police, provide rescue support up into the Royal National Park and provide assistance if needed, to our neighbouring clubs to the south. This requirement is carried out by a handful of members who have their names and contact numbers registered with the emergency and rescue services.

## Patrol Highlights:

- √ 105 Bronze Medallion holders undertaking patrols, 66 males and 39 females.
- √ 15 Active Reserve and Long Service Members attending and supporting our patrols
- √ 14 Cadets members (U15 members), 14 males and 2 females.
- √ Nine patrols each with an average of 10 Bronze Medallion holders and a minimum of one IRB Driver, one IRB Crewperson, two ARC holders and one Defibrillator operator.
- √ Among the nine patrols and Active Reserve members, there are 34 ARC holders and 21 IRB drivers.
- √ 62 patrol members gained 100 % patrol attendance.

## Operational Statistics:

- √ Patrol members rescued eight people during the season -
  - 6 with the aid of a rescue board
  - 2 with the IRB
- √ Patrol members took preventative action and warned or directed 64 swimmers to safer areas, ie within the flags
- √ First Aid treatment was rendered to 56 people mainly for marine stings.
- √ Ambulance called for five people
- √ Search for lost children on one occasion
- √ Shark alarm sounded on two occasions
- √ Call outs to assist research & rescue by other services on three occasions

Patrol Defaults: Surf Life Saving Illawarra recorded a total of 100 demerit points against our patrols for the 2006-07 season, with three instances of late radio log on and one instance of the IRB not been operational for more than 15 minutes. This overall was a very good result.

# Beach patrols

---

## Rescue equipment

During the year, one IRB motor was replaced, and a second will be replaced prior to the start of the 2007-08 season. One new motor has been acquired funded by Helensburgh Workmens Club, and with the assistance of a \$ for \$ grant from the NSW Government and other donations, a second new motor will be acquired during July.

Two IRBs were operational for the entire season apart from 3 weeks when one IRB was away being repaired. During this period, the remaining IRB was restricted exclusively for patrol purposes.

The base radio and base radio power supply were replaced with new units, replacing a ten year old radio. A program was also commenced to upgrade our hand held units because of difficulties with repairing and obtaining parts for the older units. With financial assistance from NRMA Insurance and a \$ for \$ grant, four new units will be available before the start of 2007-08 season.

## Report from Chief Training Officer, Peter McDonald

This being my second season as Chief Training Officer and having a better understanding of the industry practice of training and assessing under the Australian Quality Training Framework for Registered Training Organisations, and combined with the assistance of our experienced trainers and our fully implemented training aids (computer, data projector and screen) ensured another successful awards season for our club.

Seventy four awards were achieved by our members.

Having to meet the new training requirements, the training for the Bronze Medallion and Surf Rescue Certificates began before the start of the season so that members could qualify and be on the beach patrolling by the end of December.

The National Board of Lifesaving adopted the new Australian Resuscitation Council guidelines for resuscitation as of the 1<sup>st</sup> July 2006. Significant changes were made to resuscitation procedures, the main changes being 30:2 rates for one and two person operations on all patients, an initial two breaths instead of five to be known as "Rescue Breaths", the removal of pulse checks and Expired Airway Resuscitation from the resuscitation algorithm and the changing of compression operators every two minutes.

Our trainers and assessors attended an introduction session conducted by Surf Life Saving Illawarra and then introduced the new resuscitation method at a seminar held for all patrolling members at the surf club in October. This was followed up during the Proficiency tests and the new methods introduced into the BM, SRC, ARC and Defibrillator Operator awards.

Thankfully the club has a number of experienced and qualified trainers and assessors to call on; this combined with a support crew of water safety, including the WCC Lifeguards during mid-week training sessions, our trainers willing to take up some of the work load and some well maintained training equipment made the task that much easier.

Bronze Medallion awards (PUA21004 Certificate 11 in Public Safety [Aquatic Rescue])

Bobo White, Geoff Ryder, Peter Turner, Tanya Potter, Aaron Wallace, conducted the Bronze Medallion training for 18 candidates. A rewarding aspect is that six of these members are new to the club and helped boost Patrol numbers.

# Award training

---

Despite some language difficulties, Martin Lellek an exchange student from Denmark was successful in gaining his Bronze Medallion; he performed patrols before returning home proud of his achievement.

Bronze Medallion candidates were assessed as they progressed through each topic outlined in the 32<sup>nd</sup> Edition Training Manual, completing a workbook and a final written exam of 20 questions. On the practical side, the traditional Run-Swim-Run and Resuscitation are still key components combined with a rescue scenario and for new members a compulsory four hour on the job training with experienced patrol members.

Dave Winner of Coalcliff SLSC being a Certificate 1V Assessor conducted the written exam and ensured that all administrative procedures had been followed for both the Bronze Medallion and Surf Rescue Certificate courses.

## Surf Rescue Certificates (CPR Endorsed)

Evan Griffiths and Peter McDonald were responsible for the training of the 12 Surf Rescue Certificate candidates, three of these members being new to the club, the others continuing on from the Junior Section.

The Surf Rescue Certificate is now of the same competency based training system as the Bronze Medallion, with the final result being that Surf Rescue Certificate holders will only have to complete a few modules to gain their Bronze Medallion.

## Advanced Resuscitation Certificate

This season 11 members successfully gained their ARC thanks to trainers Tanya Potter, Evan Griffiths and Peter McDonald who put up their hand to take on another course, extending their training times for the season to five months.

Our past approach of encouraging members who gain their Bronze Medallion to keep training and qualify for the Advanced Resuscitation Certificate (ARC) was continued this season. Club patrol teams now have the luxury of having an average of six ARC holders on each patrol.

Special congratulations to Nathan Johnston, although visually impaired showed a high degree of competency in attaining his ARC certificate.

## Defibrillator Certificate

For two seasons the club has been in possession of a Defibrillator, thanks to the generosity of the Helensburgh Workmens Club, with another unit being donated by SLSA this season. Up until this season none of our patrol members have been qualified to use the units. Fortunately we now have 15 members and trainers trained and qualified by SLSI educators.

Initially members were selected from each patrol, so that there would be coverage for the season, should the need to use the units eventuate. With on-going support from SLSI, the club will be able to train other members in the use of the defibrillators and gain their Defibrillator Certificate.

## Silver Medallion IRB Drivers and Crewpersons Certificates

Thank you once again to Murray Dowling who took the initiative to train IRB Drivers and Crewpersons. Murray and a number of experienced drivers were on-hand to prep the IRB and put the members through various training exercises.

Seven members gained their Silver Medallion IRB Driver and eight members gained their IRB Crewperson Certificate. Congratulations to all of these members, especially Stephanie McGuinness our second female IRB driver in the history of the club, Nicole Blizzard being our first female driver back in the 1989-90 season.

This group has strengthened the club's IRB contingent supplying a majority of patrols with up to three drivers. Enthusiasm is building once again in the IRB ranks and hopefully some of these members will revive the IRB competition scene and gain further experience in these important rescue crafts.

Shannon Cummings (Certificate 1V) was on hand to conduct a written and practical examination and assess this large group, the club appreciates his assistance.

## Trainer (TAA Provide Training)

Tanya Potter and Shannon Cummings gave up some of their value time to qualify for the Trainers Certificate strengthening our group of existing trainers and assessors.

## Proficiency Tests

Two mass proficiency tests were conducted under the control of Evan Griffiths, Bobo White and Peter McDonald for both the Bronze Medallion and Surf Rescue Certificate holders, this catered for the majority of members.

Eighty one members were re-qualified and proficient for the 2006-07 season.

Advanced Resuscitation Certificate proficiency and the resuscitation component of the BM and SRC proficiency was conducted during patrols, an initiative of Evan Griffiths; this made sure all members were suitably proficient in this important role.

Fifty-six members were proficient in ARC.

IRB drivers and crewpersons were deemed proficient via demonstrations of competency during their operational activities on patrols and providing water safety for both senior and junior point scores and during award assessments.

A number of active members completed their All Terrain Vehicle (ATV) Operator Induction Accreditation.

## General

Our club was well represented by trainers at the Education Meetings conducted by SLSI during the year.

Our training officers were pleased to assist in training two candidates from other Illawarra clubs who trained with our members in the Surf Rescue and Advanced Resuscitation courses.

Our members were active in undertaking assessments for other clubs and this was reciprocated by other clubs. Thanks to Dave Winner from Coalcliff for assessing our Bronze Medallion and Surf Rescue Certificate candidates. Well done to Bobo White, Evan Griffiths and Peter McDonald for assisting with the assessing of Coalcliff award candidates.

Congratulations to all members who gained awards or kept proficient to ensure Helensburgh-Stanwell Park Surf Life Saving Club is a strong patrolling club, highly recognised by the Illawarra Branch. To all who assisted, it is greatly appreciated by the club.

## Club Management

Executive Committee – two formal meetings were convened as well as some ad hoc meetings to discuss urgent matters; matters discussed were reported to the next meeting of the Management Committee, and related to naming of the new surf boat, boat, selection of nominees for SLSI Awards of Excellence, and selection of Club member of the year.

Management Committee - met monthly (except in March and May 2007) to deal with correspondence, monitor income and expenditure, approve payment of accounts, and receive reports from Club officers.

Fourteen officers were elected to this Committee but average attendance of Committee members at these meetings was 9, and was a slight improvement on last season.

Occupational Health and Safety Committee – this Committee met once to plan a building inspection, still to be carried out.

Competition Committee – efforts were made to re-establish this Committee at a Special General Meeting called for 15 October 2006, but the committee was not formed and did not function during the year.

## Membership Fees

The Junior Activities Committee advised at the end of the year that it was necessary to increase Junior Activity Membership fees for 7-13 year old members for 2007-08 season to \$50.00 to cover actual costs being incurred for these members.

Membership fees for all other membership categories will remain the same as the 2006-07 season.

The maximum membership amount payable by a family group of two parents and their school age children (up to and including High School level), will increase to \$130.00 reflecting the increased Junior Activity Membership fee.

New procedures were introduced for the collection of fees last year, with all members of the Club at 1 July 2006 being sent invoices for their 2006-07 fees. This resulted in a dramatic improvement in the payment of fees on time, with less than 20 members had not renewed their membership and paid their fees at the end of November.

Invoices for fees for 2007-08 season will be issued with the August Park Bench.

## Membership Forms

It is an SLSA requirement that members renewing their membership complete the SLSA Membership form each year. New procedures and an improved checking process were introduced this season to ensure all members had completed forms, with less than 5% not completed at end November.

## Welfare of Members – Member Protection Policy

To promote Surf Clubs and Club activities as a safe place for younger people, SLSA and SLS NSW sponsored a “Working with Children Check” which in NSW require members who may come in contact with younger people in their work or sports environment to sign a Prohibited Employment Declaration and Consent Form.

This program was actively supported by the Executive Committee and the Club overall with the Deputy President Paul Potter being nominated as the Club’s Child Protection Co-ordinator

## **Grievances**

The opportunity was again taken to remind members by medium of The Park Bench of the correct procedures to be taken if they have a complaint or grievance through the Park Bench. A notice was also placed on the Notice Board within the Club building.

Two members raised concern regarding the conduct of the election of officebearers; both matters were dealt with by the Management Committee with the correct procedures now documented for future reference.

During the year a small number of members raised issues with individual members of the Executive Committee with these being later dealt with at the next Management Committee meeting.

## **Membership Development**

Stephanie McGuinness was nominated to attend a four day Youth Leadership Development Camp held in April 2007. The program run by Surf Life Saving NSW at Brooklyn, provided for only two members from each Branch, regrettably Stephanie was not selected by SLSI.

Cameron Baillie, Ahron Burke and Toby Dent attended a weekend Rookie Leadership Development Camp in December 2006 run by SLSI. A few weeks later, SLSI sent a letter complimenting the three members on their excellent behaviour and participation in the activities.

Some of our new members and younger members were selected by the Club Executive and invited to participate in a workshop/seminar to consider options to alter the Club structure and the development of a five year plan.

## **Membership Recruitment**

Peter McDonald co-ordinated a program and was assisted by other members with visits to local primary schools addressing children about the surf safety, joining the surf club and how to become involved. The results with a large influx of new Junior Activities members from both the local area and as far north as Engadine and Menai were positive, and further programs are proposed.

Two Club members suffered minor injuries whilst undertaking surf life saving activities during the year.

These two members sought re-imbursement of medical costs from the NSW Government Emergency and Rescue Workers Compensation Fund, these members being Dick Cavanagh (injury at 2006 AGM) and Terry Wood (injury during 2007 Ocean Swim)

## Communication with members

The Publicity Officer Tanya Potter continued publication of the Park Bench, with six issues from August 2006 to June 2007.

A Centenary Newsletter was commenced with the first issue in June 2007.

Julie Humphries provided regular reports to the two local monthly publications, whilst a number of reports of Club activities also appeared in Wollongong local newspapers.

The Club website was upgraded and expanded during the year.

# Statutory Reports

---

## Annual Statement for Incorporated Associations

The Annual Statement for 2005-06 financial year, as required under the Associations Incorporations Act 1984 was approved by members at the Annual General Meeting held on 23 July 2006, and submitted to the Office of Fair Trading on 14 August 2006.

## OH&S

Don Harris and Roger Hendry took over responsibility for monitoring of OH&S compliance within the Club. At the end of the year, they reported there were no matters of concern, and intended to complete a full inspection of the Club premises and equipment prior to the commencement of the 2007-08 season.

Wollongong City Council as owner of the building continued to organise regular checks of fire extinguishers and electrical appliances.

## Environmental management

Refuelling of IRBs and the quad bike within the boat shed area continue to present a risk of an environmental incident. Similar to last year, the risk continues to be mitigated by the availability of a spill kit located in the boat shed, and briefing of IRB crews and patrol members on their duty of care when refuelling.

Exemption was again granted by Sydney Water allowing the use of water for life saving operational activities outside normal restrictions. This exemption was monitored during the year to ensure it was not abused by Club members.

Preliminary discussions took place with Wollongong City Council about recycling facilities for cans and bottles and will be pursued in the 2007-08 year.

## Food business notification

Notification and registration of the Club as the operator of a food business (dispensing of drinks and preparation and sale of food items) was forwarded to the NSW Food Authority in October 2004. To meet our obligations, best practice guidelines and cleanliness standards for food handling need to be on display in the bar and kitchen area.

## Asset Register

The Asset Register was maintained on a computer database and was updated to effect changes. Basic information about surf craft (boards) held by the Junior Activities Committee was added and will be further expanded during 2007-08 season. A summary of the Register is included in this report.

## Liquor Licence

The Club continues to hold a Function Licence issued in the name of Harley Dreghorn (Licence no 24003604). Eight members who hold Responsible Service of Alcohol Certificates were qualified to serve alcoholic beverages.

The Licensing Court endorsed all applications to conduct functions during the year. Notification was sent to the Licensing Court, Police and Wollongong City Council of dates approved by the Management Committee to conduct "Coldies" functions following patrols, point score, and other Club activities. No incidents relating to the Liquor Licence were recorded during the year.

An audit undertaken by the Office of Liquor Gaming and Racing during November 2006 found that the conditions of the licence were being followed and that all necessary signs were in place. The Licensing Inspector advised that "Coldies" functions must be restricted to Club members and a procedure was required to manage this, viz a list of current members is to be accessible to bar staff. There were no other matters arising from the audit.

Amendments to the NSW Liquor Act were not progressed this year but it is likely "Coldies" functions will be withdrawn when new legislation is enacted.

Wollongong Police (Licensing Police) requested the Licensee (and licensees from other surf clubs and sporting bodies) to attend a meeting on 5 February 2007 to discuss compliance with NSW laws on under age drinking particularly at private parties (including BYO functions) held in licensed premises. The Police advised licensees of necessary procedures and a general requirement that access to parties and functions be restricted and registered with the Police.

Further consideration of these matters is required in 2007-08 in connection with the Management Committee's wish to re-introduce opportunities for private hiring of the surf club as a fund raising initiative.

## Insurance

The Club renewed insurance policies to cover fire and burglary of Club equipment contained within the Surf Club, as well as policies for theft and damage to the IRBs, surf boats and quad bike. The surf boats and IRBs are insured through brokers Jardine Lloyd Thompson whilst the quad bike and general contents are insured direct with NRMA Insurance.

Public liability insurance was effected through a policy maintained by SLSA, with a contribution of \$6.97 (plus GST) per member.

Directors and Officers Insurance was effected through a policy also maintained by SLSA at a cost of \$450.00 (plus GST).

## **Approach to possible donors**

David Anger initiated a letter writing campaign in February 2007 to seek donations from a range of companies to assist with the purchase of training boards for Junior Activities members. Regrettably none of the companies offered any assistance.

## **Stanwell Park Ocean Swim**

The Executive Committee again extends its thanks to Andrew Perrin and the Ocean Swim organising committee of Wayne Johnston, Kevin Keane and Murray Dowling, and Ken Newman from Coalcliff SLSC.

Thank you to the many Club members who assisted in organisation and running of the event, with particular mention of Sue Bell who co-ordinated the food sales and Hayley Johnstone for selling souvenir caps.

Thanks to Coalcliff SLSC members for their involvement, and for joining with our Club to make this a great community event; the support of SLSI and the assistance of Jeff Venning and Gerald Davies is also acknowledged.

The operational and risk management plan prepared for the 2005 event was reviewed during the year and updated to improve some procedures, and was successfully applied for the 2007 Ocean Swim held on Sunday 18 March.

The 2007 event took place in good weather conditions with 265 competitors entered. Cash prizes were offered for the first male and female swimmers over the line, and embroidered towels to winners in other categories, thanks to the support of MBF Travel.

\$5,420.00 was raised from this event and similar to previous years will be allocated to the Club Building Account.

## 19 May 2007 Fund Raising Night

Sue Bell and Don Burke worked together with the assistance of other members to plan, promote and run a fund raising night on Saturday 19 May with the intention of providing additional training equipment for our younger members.

Special thanks to d'Band for entertainment on the night and the many members and friends who contributed financially in some way or other, through the 100 Club, paying entry fees or enjoying a "higher than normal" priced beer or soft drink.

Thanks also to the local businesses who made cash donations or donated prizes for raffles including Orthonet Pty Ltd, Minetronics Pty Ltd, Kay & Dave Boughton, Sunrise Nursery, Bi Lo Helensburgh, Stanwell Park Kiosk, Helensburgh Liquor Stop, Binnars Farm, Al & Lissa's Meats, Good Forest Chinese, Crockers Paints Miranda and Goodman Fielder food manufacturers.

Combined with the 100 Club proceeds, donations, entry tickets to the social night, food sales and a portion of the bar profit, \$3,918.00 was raised.

## Donations and Grants

- √ Helensburgh Workmens Club through the Community Development Support Expenditure scheme (CDSE) donated \$3,428.00 for the purchase of an IRB motor and radio.
- √ Application to Clubs NSW for a further grant of \$9,500.00 under CDSE funding to purchase a replacement IRB; the result of this application had not been announced at the date of this report.
- √ Application was made to NRMA Insurance through its Community Help Program for two grants, one to purchase two hand held radios at a cost of \$1,156.00 and the second for a grant of \$1,700.00 to allow continuation and enhancement of our surf awareness program through visits to local schools. The grant for two radios was approved, the other grant was declined.
- √ Application was made to SLS NSW for a \$for\$ grant of \$2,003.00 funded by the Department of Sport and Recreation to purchase an IRB motor and two hand held radios; this grant was approved.
- √ Application was made to the Australian Government for a Volunteer Small Equipment Grant for the purchase of a new refrigerator \$1,740.00, and three external public address system speakers \$840.00. The result of this application had not been announced at the date of this report.

## Club building

---

Once again, special thanks to Peter and Sandra McDonald for their sterling efforts in maintaining the Club building in a clean and tidy condition, cleaning the main hall, kitchen and amenities, and removing rubbish almost every week. The cleanliness of the premises is first class and a credit to them. Thank you.

Very little has occurred this season, although some projects were progressed. The bar area has been modified to facilitate easier return of empty glasses on busy nights, and a new sink, counter and underbench glass washer installed. The hot water tank was also relocated to an underbench position in readiness for a new two door drink fridge to be acquired prior to the start of next season. This will see the retirement of an asset purchased at auction second hand in 1982, and considering the volume of drinks it has kept cold over the last 25 years it was clearly a good investment. Once the new fridge is installed, some timber work in the bar area will complete this project.

Application was made for a grant to purchase a new fridge for the kitchen, and even if not successful, it is intended a new two door fridge/freezer unit at a cost of less than \$2,000.00 will be obtained before the start of 2007-08 season.

The existing public address system was modified by Paul Potter at a nominal cost with two roving microphones acquired and two external speakers installed under the southern eaves on trial. To date the external speakers have proven to be satisfactory and will be monitored over the coming season.

The data projector is now fully installed in the upstairs training area, complete with pull down screen. Additional power outlets have been installed thanks to Barry McGuinness spending a few of his Sunday afternoons at the surf club.

The upgrade of the patrol room is substantially complete, with some minor work still required.

The television and video player were replaced during the year thanks to a donation from a member, with the video player upgraded to a DVD player.

A donation from Kone Elevators Pty Ltd enabled a total refurbishment of the First Aid Room to be undertaken during June. The room was stripped out, repainted and new cupboards fitted with much of the planning work done under the guidance of Peter McDonald with assistance from Geoff Coleman. Resident electrician Barry McGuinness was again called upon to rewire the first aid room.

During June some of our patrol members led by Aaron Wallace, spent a day cleaning the outside of the building in readiness for our centenary year.

The doorway to the store room opposite the First Aid Room was modified and widened by Wollongong City Council early in 2007 in readiness for the placement of a disabled surfers wheelchair at Stanwell Park. It is understood the Disabled Surfers Association will provide the wheelchair in 2007-08.

At a meeting with Council in September 2006 the Club Executive declined a request for lifeguards to use the Club kitchen to overcome a health issue with the current lifeguard facilities and a second request for allocation of one bay of the boatshed for storage of Council's quad bike and jet ski. Advice is awaited from Council on an alternative suggestion to relocate the lifeguards amenities to another part of the ground floor.

As members will be aware, the car park has been tar sealed and recently line marked. Regrettably Council regards the car park as a public facility and is not prepared to allocate any spaces to the surf club, or allow access to the car park to be restricted in any way.

On 24 January 2007 at the request of SLSI a maintenance list was prepared and submitted to Council for work to be undertaken in the 2007-08 financial year. Items included attention to corrosion of steel reinforcing bars in concrete pillars, address corrosion on steel framework of patio, rectify water leaks from roof, and under windows southern side, repair leaking taps in showers (environmental issue), repair or replace security gates near First Aid Room, and repaint external parts of building in preparation for the Centenary Year. At the date of this report very little had attended to and the various matters will continue to be pursued with Council.

## **Extensions to the Club building**

There have been no further developments with any extensions and the status is as reported in the last Annual Report.

The Executive Committee is aware of grants and \$for\$ opportunities for extensions to surf clubs, however such applications must have an approved DA with evidence of Council support. The provision of a deck on the south side, and/or additional space for storage are both high priorities.

The next step is to identify a member prepared to take on a "project manager role" to work with the Executive and oversee design, preparation of plans and specifications, obtain some realistic cost estimates for the work, and pursue the necessary approvals in readiness for lodgement of an application when invitations for further government grants are invited mid-2008.

In the meantime, the container for the lifeguard's equipment remains in situ.

# Future planning

---

## Strategic Planning and Organisational Review

On 12 August 2006, a representative cross section of 24 members, selected by the Management Committee from younger members and members new to the Club attended a workshop to consider changes to the Club structure and start on the development of a five year plan.

Some of the 24 members were not able to attend, but the 15 members who attended willingly shared their experiences and ambitions with each other. Each attendee gave a brief overview of their personal involvement in the Club and where they wanted to see the Club and themselves in five years time. Each one confirmed they were committed to continuing with the Club, some with aspirations of moving into an Executive position but all with firm commitments to be more involved in the short term future than just as a patrol member.

Some options to change the committee structure were considered with a preferred option of focus groups taking more responsibility for specific areas of the Club, preparing realistic duty statements for all positions on committees and sub-committees, and clear terms of reference being defined for the Management Committee and all sub-committees.

Since the workshop, the proposals were developed and presented initially in a briefing session to all members at a Special General Meeting, and secondly as a new structure that could be introduced with minimal changes but still follow the option preferred by the attendees at the workshop.

A brain-storming session identified some actions that could be taken to further improve the club, with highest priorities being communication with members, succession planning and opportunities for members to gain experience before stepping into a position on the Club Executive or Management Committee. These and other matters will be included in a five year plan to be developed in 2007-08.

## Club Point Score and Championships

Mark Thompson took over organisation and running of the Sunday morning point scores and Club Championships. Only a small number of members took part in the point score events.

The Club Championships were not held this year. On the first advertised date, it was not possible to provide an IRB as required for water safety, with only one operational IRB. The event was postponed to a later date but on that date there were insufficient competitors in attendance to run the Championships.

## Surf Boat Rowing

Boat Captain Mark Wallace reported that the highlight of the year was the christening of another surf boat. This boat was named the "George Jardine" after a Life Member of the Club and past winner of many surf belt races in the 1940s. George is probably best remembered for his toughness and skills on the rugby league field playing for St George in the 1940-50 era.

With six crews at the start of the season, the new boat was urgently required. The U/23 crew of Daniel Wright, Daniel Garforth, Kean Peard, Dave Gwynne and Brendan McAlpine as sweep, led the way with a 3<sup>rd</sup> in the NSW Premiership series, 4<sup>th</sup> in the South Coast Boat series, and 3<sup>rd</sup> in the Open Branch Championship. The Vets crew (o/40s) of Phil Doran, Ian Van Zyl, Don Burke, Kevin Morton and Mark Wallace as sweep, who although missing the first round, managed to gain 2<sup>nd</sup> place in the South Coast Boat series missing out by only 3 points in winning the Vets category.

The senior ladies crew of Karen Burke, Phillipa Amery, Chantelle Thomas, Nicole McAlpine with Brendan as sweep, were up against stiff opposition but did well overall. The u/23 girls crew of Tegan Heiler, Ricki Van Zyl, Amanda Mercer, and Alyse Wright (all very young boaties) and Brendan McAlpine as sweep also did well against the more experienced crews from other clubs.

The u/23 Blue Crew did not compete this season as a result of injuries early in the year.

This was the largest contingent of boaties for quite a while and all represented the Club proudly.

The boaties extend their personal thanks to their supporters this year particularly the fellow members and parents who have attended boat carnivals and helped out as boat handlers, and who help make the sport so much more enjoyable. Special thanks to the companies who have provided financial and other support this season including Metropolitan Colliery, DBT Australia, Kitco, Logical, and Southern Engineering Services.

# Winter Swimming

## Report from Stanwell Park Sea Eels Secretary Phil Kelly

The Sea Eels finished the 2006 winter swim season in a stronger financial position than the previous year, met their goals and provided many existing and a few new swimmers with achievable challenges.

51 members commenced the 2006 season, our 18<sup>th</sup> with two Associates and 49 active swimmers, some more actively swimming than others. On the 20 Sunday morning swims, there was an average of 35 swimmers. Overall, 11 swimmers gained 100% attendance and the record of five guests in our Bring-A-Friend Day was maintained.

We were particularly pleased to have awarded well-deserved Life Membership of the Sea Eels to Rod Hampson at our last AGM.

Donations were made to CRAM House, and Helensburgh-Stanwell Park and Coalcliff SLSCs.

Newly elected Chairman Damian Lloyd, Captain Ian Van Zyl and others had a pretty easy time of it last year, thanks to the continuing support of all members and their families. 2006 was one of those years where we achieved a lot, were constantly surprised by how quickly the season was progressing, and how wonderful the weather was.

# Winter Swimming

Bill Searle's 1000<sup>th</sup> Swim: Two Sea Eels, Tony Baillie and Phil Kelly intrepidly responded to an invitation from the Wollongong Whales to mark Bill's 1000<sup>th</sup> Winter Swim. One thousand attendances over 50 years duration is a remarkable achievement in any sport and we felt honoured to be invited. As it turned out, the Sea Eels were the only club other than the Whales who were there. Both swimmers made it through several rounds, but were beaten by the eventual winner of the handicapped event.

SCWSA Championships: Wollongong Whales hosted the South Coast Winter Swimming Association Championships at the Continental Pool, Wollongong. Our swimmers represented our club splendidly gaining second place overall, and just missing out on winning the A Grade Relay.

Everyone was on hand to assist the hosts in disposing of the refreshments at the Championship Dinner at the North Wollongong Surf Clubhouse. Thanks to the bus driver for getting everybody home. The entertainment by Rugby League legend John "Bomber" Peard was absolutely priceless and had us in stitches for over an hour. Barney was especially pleased to be on the lam with his mates. Our Patron, Col McArthur handed over a cheque to the SCWSA.

Cram House Visit: This year we hosted the children from CRAM house, some of their carers and family members at the Helensburgh Bowling Club rather than the Surf Club where the stairs become difficult carrying children in wheelchairs. It was a fantastic day, once we got it arranged.

The kids ate heartily, some shared a beverage or two, but all enjoyed a few games of bowls. Barry Thompson and Brian Taylor from the HWC social golf club donated \$250.00 to CRAM House being proceeds from the annual Phil Anger Golf Day between HWC and the Surf Club.

WSAA Championships: The Championships of the Winter Swimming Association of Australia were held in Western Australia on Sunday 17 September 2006. We didn't send a team, due to distance and cost, mainly because the Aussie Surf Lifesaving championships were also to be held in the west, and several families would need to travel across the continent twice.

Surf and Turf Night: This was a new format held as previously at Stanwell Park Surf Club and was another successful social event. We had a most delicious Seafood Chowder, followed by a catered buffet dinner. There were many raffles held and a good night had by all.

Christmas drinks: Christmas Drinks were again hosted by Damian Lloyd and Jo Richards. As usual, the well-behaved children kept their parents under control and tucked them into bed when they got home. The kids had the run of the pool while the grown-ups cooled off with a few quiet home brews and other libations on the very sunny afternoon.

2006 Sea Eels Championships: Club Championships were held over from the advertised Sunday due to unpleasant sea conditions at Coalcliff Pool. These conditions were king tides sweeping over the pool, bringing in hundreds of blue bottles. There are no favourites; this is as serious a competition as we can make it.

This season the Sea Eels had 11 swimmers who achieved 100% attendance. The 2006 Slippery Eel was Peter McDonald, a fitting recipient and obviously one of our most capable foxers, hitherto unnoticed.



# Financial Reports

---

Separate financial accounts were maintained for the four sections of the Club – General Account, Trading Account (refreshment sales), Junior Activities Account and Winter Swimming Group Account, with each being managed by the elected treasurer of each section and under the overall control of the Executive Committee through the Treasurer.

All accounts were computer based, but not on a common financial accounting program. All accounts are presented as GST exclusive amounts.

## Financial Position

At the end of the financial year, 31 May 2007, the Club was not in debt to any supplier (other than within 30 day trading terms), and was in a financially sound position. The Executive Committee is of the opinion that the Club will be able to pay all debts as and when they fall due.

The Committee is aware it will probably be necessary to enter into a short term financial arrangement with an external party to meet the upfront costs of printing the Centenary History Book, but this action will only proceed with the endorsement of members

Trade Creditors, General Account - an amount of \$5,328.05 was recorded in the accounts at 31 May 2007 following the issue of Purchase Orders for two sweep oars and items for 2007 Presentation Night. With goods received and payments made up to 10 July 2007, only one Purchase Order remains unfilled (sweep oars) for \$2,200.00.

Trade Debtors, General Account – at 31 May 2007, unpaid invoices totalled \$3,799.70. Of this \$3,428.00 has since been paid being re-imbusement for rescue equipment purchased by donation, \$50.70 payable by Junior Activities for cheque adjustment, and the balance payable by members (fees \$125.00, training manuals \$96.00 and contra re-imbusement of \$100.00).

Donations and income from fund raising activities which had not been spent prior to 31 May 2007 and membership fees paid in advance for 2007-08 season (total amount \$9,536.08) were accrued and transferred to 2007-08 income.

The General Account includes an amount of \$6,198.56 held for the boat rowing section.

Both the Junior Activities section and Sea Eels ended the year with increased cash holdings, whilst funds were retained in the Trading Account for the purchase of a new bar fridge.

## Donations

Donations made to the Club were separately identified in the financial accounts to comply with requirements of the NSW Charitable Fundraising Act, 1991. The authority held by SLS NSW to fundraise under this Act, CFN 11033, was renewed from 5 May 2004, current to 5 May 2009, and specifically notes Helensburgh Stanwell Park SLSC (and other SLSCs) as a “branch”.

All donated funds were expended for the purpose for which they were sought, this being primarily for surf life saving rescue and training, other than for the following exceptions –

- donations made to the Winter Swimming Group which were specifically sought for CRAM House.
- donations made to the Club which were specifically sought for competitive activities such as the purchase and operation of the surf boats
- donations made to the Club which were specifically sought to offset Club costs incurred in competitive activities (ie payment of carnival entry fees)

No member of the Club was entitled to or gained any personal benefits from any donations received.

## GST reporting

Quarterly reports were submitted by the Public Officer to the Australian Taxation Office for the Club as a single entity reporting body, but incorporating the four sections (or operating accounts) of the Club.

A review undertaken by the Public Officer, Treasurer and Auditor confirmed that GST was correctly added to income, other than GST free income, and that claims made for a refund where GST had been paid by the Club, were correct. At 30 June 2007, the Club was not in debt to the ATO, and there were no outstanding GST reports.

## Auditor

SLS NSW has recently advised Clubs of reporting requirements under the Charitable Fundraising Act. This will require the Club to apply for an exemption to the rule if we wish to continue with Evan Griffiths as Auditor. At this stage it is unclear whether such an application will be successful given the amount of income received and value of assets held by the Club.
